#### New Torch Safety Guidelines NRCA changes its torching recommendations, affecting the CERTA program

Torch-applied polymer-modified bitumen sheet products have been used successfully and safely in North America since the late 1970s; however, in a limited number of situations, rooftop fires have occurred during the application of these products.

NRCA is of the opinion torch-applied polymer-modified bitumen sheet products can be used safely if roof decks, roof membranes and construction details are designed properly and installed with fire safety techniques taken into consideration. NRCA recommends designs be based on guidelines contained in The NRCA Roofing Manual and torch applied applications should only be carried out by CERTA-trained workers.

#### The NRCA Roofing Manual

Torch-applied polymer-modified bitumen sheet products are addressed in *The NRCA Roofing Manual: Membrane Roof Systems*—2019. Specific assembly configurations for which NRCA recommends torch-applied products are described in Chapter 1-Roof Assembly Configurations. These include torchapplied roof systems over non-nailable (concrete) and insulated roof decks except combustible (wood) roof decks.

NRCA is particularly concerned about the potential for fire during the installation of torch-applied membrane sheets over combustible substrates, such as wood roof decks, wood panel sheathing, wood planks and boards, and wood blocking. As a result, in the 2019 volume, NRCA no longer recommends designers specify torch-applied polymer-modified bitumen sheet products over combustible roof decks even if a thermal-barrier insulation layer is installed over a combustible roof deck.

NRCA considers the potential fire risks associated with torchapplied applications over combustible roof decks to outweigh the advantages torch application provides. Also, alternative application methods for polymer-modified bitumen sheet products have proved to be successful. Designers should consider alternative application methods, such as cold adhesive application, when polymer-modified bitumen sheet products are specified over combustible roof decks.

NRCA's recommended guidelines for construction details using torch-applied polymer-modified bitumen sheet products are provided in the 2019 volume's Chapter 10-Construction Details. These are unchanged from the previous edition. Separate recommendations and construction details are provided for noncombustible substrates and combustible substrates.

Because compliance with The NRCA Roofing Manual is a specific provision of the CERTA program's best safety practices, NRCA's new recommended exclusion and the 2019

volume's Chapter 10 recommendations and construction details also apply to the CERTA program.

#### **OIRCA Bulletin**

In December 2018, the Ontario Industrial Roofing Contractors Association (OIRCA) issued a bulletin, "OIRCA Submits Ontario Fire Code Changes to the Ontario Fire Marshal," detailing changes the group has proposed to Ontario's fire code.

Specifically, OIRCA has proposed open flame torches no longer be used to apply roofing materials at roof flashings and penetrations. OIRCA indicated most torch fires originate at roof flashings and penetrations; fewer start in the fields of roofs.

OIRCA also has proposed a hand-held thermal imaging camera be employed as a part of Ontario's code-required, two-hour fire watch.

OIRCA's bulletin indicated its board of directors strongly believes an aggressive position must be taken to reduce the potential for future fires when using torch-applied roofing products. Awareness of torching-related fires is spreading as municipal fire departments, provincial fire marshals and the insurance industry take notice. Rather than having these groups dictate the roofing industry's future, OIRCA is seeking a better solution and believes its proposed changes to Ontario's fire code will do the job.

#### **Closing Thoughts**

If you are involved in the manufacture, design or installation of torch-applied, polymer-modified bitumen sheet products, you should be aware of NRCA's new recommended exclusion of torching over wood roof decks and its applicability to the CERTA program.

Although NRCA and the CERTA program have not adopted OIRCA's proposed fire code changes, NRCA applauds OIRCA's efforts. Furthermore, NRCA agrees the roofing industry, not outside entities, should control its future.

NRCA's recommendations regarding the use of polymermodified bitumen sheet products are provided in *The NRCA Roofing Manual: Membrane Roof Systems*—2019.

#### NRCA 10 @ 10

Roofing Day in D.C. 2019 was successful. Roofing industry professionals from all segments of the industry and throughout the U.S. convened in our nation's capital April 3-4 for Roofing Day in D.C. 2019. The event brought the roofing industry together to speak with one voice in the halls of Congress. Participants carried the industry message regarding key issues, including the need for enhanced workforce training incentives, immigration reform that addresses workforce needs and a robust buildings component within infrastructure legislation. On April 3, attendees were welcomed by NRCA CEO Reid Ribble and received advocacy training to prepare for meetings with members of Congress. They also were addressed by Reps. Lloyd Smucker (R-Pa.) and Denver Riggleman (R-Va.) before enjoying a networking reception. On April 4, participants headed to pre-arranged meetings with lawmakers and congressional staff on Capitol Hill, delivering the industry's priorities straight to their representatives. NRCA wants to thank all participants and partner organizations for helping make this event successful. Save the date for Roofing Day in D.C. 2020, which will be held April 21-22, 2020, at the Washington Marriott Wardman Park hotel in Washington, D.C.

Legislation to address workforce shortages introduced. NRCA is supporting legislation to address the growing issue of workforce shortages. Reps. Lloyd Smucker (R-Pa.) and Francis Rooney (R-Fla.) have introduced the Workforce for an Expanding Economy Act (H.R. 1740), which would establish a market-driven visa system that allows temporary foreign workers to fill job openings for employers with year-round, nonfarm positions. The new system will be governed by market forces, protect U.S. workers and enable job creators to legally obtain the workers needed to meet demand and grow their businesses and the economy. The new system would be available to employers in counties or metropolitan areas where the unemployment rate is less than 5%, and it will combat illegal immigration by requiring participating employers to use the E-Verify program to verify the work status of new hires. Roofing Day in D.C. 2019 participants advocated for H.R 1740, and NRCA is pleased the bill has gained bipartisan support with Rep. Susan Wild (D-Pa.) signing on as a co-sponsor. NRCA is urging members to send an email to their representatives in support of this bill by clicking here to visit the NRCA Grassroots Advocacy Network.

Legislation to expand workforce training incentives. As Congress considers reform of the Higher Education Act, which provides funding for student financial aid for postsecondary education, NRCA is working to develop support for two bills introduced in March designed to be included in a broader package of reforms of the HEA. The Jumpstart Our Businesses by Supporting Students (JOBS) Act (S. 839) by Sens. Rob Portman (R-Ohio) and Tim Kaine (D-Va.) would extend eligibility for Pell Grants to short-term workforce programs. This would provide more students with access to the types of training programs being developed within the roofing industry. Also, the College Transparency Act (S. 800/H.R. 1766) by Reps. Raja Krishnamoorthi (D-III.) and Paul Mitchell (R-Mich.) and Sens. Bill Cassidy (R-La.) and Elizabeth Warren (D-Mass.) would improve access to postsecondary educational and workforce data. This will enable students and parents to better compare the costs and economic returns of pursuing careers in roofing and other trades with the cost of pursuing college degrees. Participants in Roofing Day in D.C. 2019 advocated for these bipartisan bills during their meetings with lawmakers and urged they be included in broader legislation to reform the HEA.

A robust buildings component for infrastructure legislation. Another focus for Roofing Day in D.C. 2019 was support for including public buildings in infrastructure legislation now being considered by Congress. Roofing Day in D.C. participants urged lawmakers to recognize the role of the built environment, which includes elements critical to our communities, such as schools, airports, hospitals and other public buildings. A key component of any infrastructure package should be The Public Buildings Renewal Act (H.R. 1251) by Reps. Earl Blumenauer (D-Ore.) and Mike Kelly (R-Pa.) to provide new financing options for improvements to public buildings. This bill would spur private investment in public building infrastructure in desperate need of upgrading through an expansion of public-private partnerships, which have been critical as a means of delivering projects on time, on budget and with greater value to taxpayers. Passage of infrastructure legislation that makes needed investments in public buildings and other infrastructure in a fiscally responsible manner is an effective way to sustain strong economic growth and invest in the future of our nation.

More visas for H-2B seasonal guest worker program. The Department of Homeland Security announced it will grant 30,000 additional visas for the H-2B seasonal guest worker program during the second half of fiscal year 2019. The visas will be available only to applicants who have held H-2B status in at least one of the past three fiscal years. Congress granted DHS the authority to issue more visas beyond the statutory cap of 66,000 per year after lawmakers failed to pass legislation to lift the cap, as NRCA and other business groups had urged. NRCA sent a letter in February urging then-Secretary of Homeland Security Kirstjen Nielsen and Secretary of Labor Alexander Acosta to provide additional visas based on economic demand to help meet the workforce needs of the roofing industry. Given applications for H-2B visas totaled more than 100,000 for the second half of 2019, the allocation of 30,000 is an improvement compared with the 15,000 granted in 2018 but still short of the amount needed to meet the workforce needs of seasonal businesses. Details regarding eligibility and filing requirements is expected to be made available by the agency soon.

**Expired tax provisions.** The House Committee on Ways and Means held hearings to review certain expired tax provisions not included in the Tax Cuts and Jobs Act of 2017. The focus on expired tax provisions comes after a bipartisan group of senators introduced the Tax Extenders and Disaster Relief Act of 2019 (S. 617), legislation to extend many expired tax provisions and disaster relief provisions. The legislation includes an extension of several tax credits and deductions designed to incentivize energy-efficiency improvements to commercial and residential buildings through the end of 2019. Sources indicate Senate Finance Chairman Chuck Grassley (R-Iowa) wants to move forward on this legislation, but Democrats who control the House appear to be split on whether to proceed with these expired tax provisions at this time. In addition, the committee approved—with

bipartisan support—bills designed to boost retirement savings, redesign the IRS and provide states with flexibility to implement reforms designed to help unemployed workers more quickly rejoin the workforce.

Main Street Certainty Act introduced in the Senate. Sen. Steve Daines (R-Mont.) has introduced the Main Street Certainty Act, legislation to make permanent the 20% tax deduction for qualified business income of pass-through businesses under Section 199A of the tax code. This deduction was established by the Tax Cuts and Jobs Act of 2017 to provide "main street" businesses that operate as passthrough entities with tax relief on par with corporations. Under current law, the deduction is scheduled to sunset at the end of 2025, and as a result, Congress will need to pass legislation to extend or make the deduction permanent to prevent a tax increase for pass-through businesses. Similar legislation (H.R. 216) has been introduced in the House and has some bipartisan support. NRCA recently joined with other business groups to urge House and Senate leadership to consider bills to prevent future tax increases as soon as possible. However, the outlook for enactment of this legislation given a divided Congress is highly uncertain at best.

**Regular rate of compensation regulation.** The Wage and Hour Division of the Department of Labor issued a Notice of Proposed Rulemaking to clarify the benefits that must be included in calculating the "regular rate of compensation" for purposes of determining overtime compensation under the Fair Labor Standards Act. As employers provide more generous benefits to attract and retain employees in the current competitive labor markets, litigation has emerged regarding the benefits that should be included when determining overtime compensation. Under the proposed regulation, numerous employee benefits would be excluded from the regular rate calculation. The NPRM was published in the *Federal Register* March 29 and can be viewed by clicking here. Comments are due May 28.

Joint employer regulation. The Department of Labor issued a Notice of Proposed Rulemaking that defines when employers will be joint employers and therefore liable for another employer's violations under the Fair Labor Standards Act. Unlike the National Labor Relations Board joint employer problem where there is an unworkable standard in place because of the board's Browning-Ferris decision, the problem under the FLSA is there have been numerous court decisions that have created a patchwork effect and causes severe problems for companies operating nationally or in multiple jurisdictions. In the NPRM, the department proposes a clear, four-factor test based on well-established precedent designed to provide employers with clarity regarding what constitutes joint employer status; offer guidance on how to apply this test; explain what additional factors should and should not be considered; and clarify that a particular business model, certain business practices and certain contractual agreements do not make joint employer status more or less likely. The NPRM was published in the Federal Register April 9, has a comment period ending June 10 and may be viewed by clicking here.

**Court ruling could reinstate revised EEO-1 survey.** In March, a U.S. district judge sided with plaintiffs challenging the decision of the Trump administration to block the Equal Employment Opportunity Commission's revised EEO-1 survey from taking effect. In September

2016, the EEOC issued the revised EEO-1 survey that must be completed and submitted to the agency by employers with 100 or more employees and government contractors with 50 or more employees. Before issuance of the revised survey, business groups had argued it would vastly expand reporting requirements for employers without providing the EEOC with significant useable data for going after pay discrimination—the stated reason for expanding the survey. It is likely the district court decision will be appealed to a higher court, and a decision on such an appeal is expected soon. It is not yet clear whether employers will have to submit data under the new survey in the upcoming reporting period closing May 31, and further guidance from EEOC is expected.
